I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, hold harmless and promise forever not to sue Boston Badminton LLC and USA Badminton, their officers and staff, volunteers, heirs, sponsors and/or agents ("releasees") with respect to any and all injury damage and loss arising from my participation, whether caused by the negligence of the releasees, the condition of the premises or otherwise, except that which is the result of gross negligence or wanton misconduct to the fullest extent permitted by law.
5. I agree to be bound by the rules and regulations of Boston Badminton LLC, the Badminton World Federation and USA Badminton I hereby stipulate that I am eligible to participate in the various sporting activities for which I am applying and that I understand that the above mentioned make no representation or warranty with respect to the condition of the premises or the operation of event.
6.
